Sub.: Disclosure regarding payment of Interest / Principal on Non-Convertible Debentures (NCDs)

As informed earlier, certain Lenders of the Company (Banks and other Financial Institutions) have entered into an Inter-Creditor Agreement (ICA) for arriving at the debt resolution plan in accordance with the circular dated June 7, 2019 issued by the Reserve Bank of India on Prudential Framework for Resolution of Stressed Assets.

In the interim pending Debt Resolution, the Lead Bank has directed the Company to refrain from any debt servicing. Accordingly, as directed by the Lead Bank, as regards the Non-Convertible Debentures (NCDs) (ISIN - INE217K07927 and INE217K08057), on which interest was due on October 4, 2020 and (ISIN - INE217K07AK7) on which interest / principal is due on October 5, 2020, has not been paid.
